C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. - Review area included isolated waters with no substantial nexus to interstate (or foreign) commerce.
 - Prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area would have been regulated based solely on the "Migratory Bird Rule" (MBR).
- Waters do not meet the "Significant Nexus" standard, where such a finding is required for jurisdiction. Explain:

On July 16, 2019, USACE personnel Roberta Budnik and Jesse Dewitt conducted a site visit to inspect the southern areas of Black Lake to verify whether any culverts or hydrologic connections would be possible and connect the wetland complex. During the site visit, there were culverts identified running east/west under side roads; however, there were no culverts identified that would allow the water to flow south. The terrain on the north, east, and west side of Black Lake are higher and can easily be seen in LIDAR images of the region. Aerial imagery identified what we thought was a ditch connecting Black Lake to the eastern wetland complex; however, during the site inspection, it was not a ditch but an ATV/UTV trail. No connections to any other waters that are known to connect to navigable waters were identified during the site visit.

Per the Cook Inlet mapping system, Black Lake and adjacent wetlands are part of a spring fed system with no visible channels draining the lake. There is one channel on the north side of the lake; however, the channel flow would be into Black Lake and not out of Black Lake due to the elevation change. The channel is a few hundred yards long and dead-ends near the road on the east side of Black Lake with older imagery not identifying that channel more than a short distance past the current endpoint. NWI has the area identified as PEM/S1B and PAB3H with no connection to any other waters.

During the site visit, the vegetation was identified as a mixture of FACU, FACW, and FAC plant species. The FACW species Black spruce (*Picea mariana*), except the areas around the border of Black Lake, was well grown and showing no signs of stunted growth, which is an indicator the areas are drier and/or uplands. The vegetation on the north side of East Merrill Circle contained only FACU or FAC species, which contained healthy White spruce (*Picea glauca*), a FACU species that does not grow in wetland conditions. The areas on the west side of Dimond Way appear to be in a transition phase from wetlands to uplands as the area contained large areas of Fireweed (*Chamaenerion angustifolium*), a FACU species that does not grow in wetland areas. From previous observations of disturbed and transitional areas, Fireweed tends to be one of the first succession plants in areas of conversion due to its prolific growth rate and seed dispersal.

In consideration of the above information with current and historic aerial imagery, the USACE can find no connection from Black Lake and its adjacent wetland complex to any jurisdictional Waters of the U.S. Therefore, it has been determined Black Lake and adjacent wetlands are isolated and not jurisdictional under the Clean Water Act.


