Summarize rationale supporting determination: Gastineau Channel is a Navigable waterbody. There are anadromous fish steams within 2 miles of the proposed project location that support federally managed fisheries resources (i.e. Chum, Coho, Pink, Chinook, and Sockeye Salmon). Interstate and foreign travelers harvest salmon while engaging in guided recreation/sport fishing in the Juneau area. Fish that out-migrate from and in-migrate to these anadromous fish steams are caught by commercial and subsistence fishers in navigable waters (i.e. Gastineau Channel, Stephens Passage, and Auke Bay). Gastineau Channel is used to transport commerce such as goods and services via ships and barges. Also, these waters are used by ocean going cruise ships and by commercial guides to transport tourists to Juneau, Petersburg, Sitka, Haines and other tourism related establishments in the project vicinity for recreation such as wildlife viewing, hunting, and kayaking.

Summarize rationale supporting conclusion that wetland is "adjacent": The subject wetlands are located on a landmass that is surrounded by the Mendenhall Wetlands which is located on either side of Gastineau Channel. The Mendenhall Wetlands are subject to the ebb and flow of the tide and the subject wetlands have a direct hydrologic surface connection to the Mendenhall Wetlands. The subject wetlands are located less than 200 feet from the main channel of Gastineau Channel and are considered adjacent to Gastineau Channel which is a TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
