SECTION III: CWA ANALYSIS

A. TNWs AND WETLANDS ADJACENT TO TNWs

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. Summarize rationale supporting determination: The Fish Creek is an anadromous fish bearing stream that support federally managed fisheries resources, Pink (*Oncorhynchus gorbuscha*), Chum (*Oncorhynchus keta*), Coho (*Oncorhynchus kisutch*), Sockeye (*Oncorhynchus nerka*), and Chinook (*Oncorhynchus tshawytscha*) Salmon. The Fish Creek empties directly into Fritz Cove which is a TNW subject to the ebb and flow of the tide. Interstate and foreign travelers harvest salmon while engaging in guided recreation/sport fishing in Fish Creek as well as within Fritz Cove and Gastineau Channel. Fish that out-migrate from and in-migrate to Fish Creek are caught by commercial and subsistence fishers in navigable waters (i.e. Gastineau Channel, Fritz Cove, Stephens Passage, Frederick Sound, Lynn Canal, Chatham Strait, and Icy Strait). The Gastineau Channel, and Fritz Cove are used to transport commerce such as goods and services via ships and barges. Gastineau Channel and Fritz Cove are used by ocean going cruise ships and by commercial guides to transport tourists to Juneau, Sitka, Gustavus, Haines, Angoon, Hoonah, Petersburg and other tourism related establishments in the project vicinity for recreation such as wildlife viewing, hunting, fishing, and kayaking.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The subject wetlands are located on a landmass that is directly adjacent to the Fish Creek and Fritz Cove. Fritz Cove is subject to the ebb and flow of the tide and the subject wetlands have a direct hydrologic surface connection to Fish Creek and Fritz Cove. The subject wetlands are located approximately 3 miles from the main channel of Fish Creek and are considered adjacent to Fish Creek, Gastineau Channel, and Fritz Cove which are TNW's.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
