**C.** Additional comments to support AJD: Both the NWI and the local wetland mapping efforts indicate the project site is an upland. The town of Ninilchik is situated on a ridge between the Ninilchik River and Deep

Creek. Few wetlands are located between these streams as precipitation and snowmelt rapidly run off of the upland ridge.

The proposed project would be constructed primarily on an existing gravel pad. No indicators of hydrology are seen in the aerial images of the vegetated portions of the lot. The soil survey lists the project area as "urban land". However, the soil across the street from the project location is mapped as non-hydric. The vegetation signature on both sides of the street is similar and it is presumed the non-hydric soils extend to the project location.
