This information is sufficient for purposes of this AJD.

Rationale: The site is on a 5-10 % convex undulating slope. Based on a site determination by the applicant, there were no positive wetland hydrological indicators. Soils contain organic sapric layer to 8 inches depth; 8-12-inches depth contain a dark silt loam soil; and below 12 inches there as gravel. The vegetation was dominated by 80 % Equisetum arvense (FAC), 15% Salix pulchra (FACW), and 10% Salix reticulata (FAC). Less dominante plants were 5% Lupinus arctcus (FACU), 5% Bistorta plumose (FACU), 2% grass, 2% Dryas spp. (FACU) and a trace of Aster spp.
