**B. Typical year assessment(s):** NA

**C. Additional comments to support AJD:** The review area is a 1.38 acre lot near the intersection of the Sterling Highway and Rose Avenue. Neither the NWI nor local wetland mapping indicate the site is a wetland. The NRCS soil survey states the soils are non-hydric with a depth to water table of more than 80 inches and a FAC to FACU vegetative community. Aerial imagery shows the western third of the lot has been graveled. The middle third has a visual signature typical of uplands in the Anchor Point area. The eastern third appears to be cleared of trees and dominated by grass. Nothing about the site contradicts the findings in the NWI/local wetland mapping.
