The 4.41 acres of wetland within the review area extends west, southwest onto an adjoining parcel. That parcel is not within the review area of this AJD. Both the NWI and local wetland mapping indicate the subject wetland is isolated. The Borough's terrain mapping indicates the wetland is in a depression that contains no outlet.](#)
