- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: Lot maps show this subdivision to be located on the south bank of the Koyukuk River bluff. The property appears to be located near the outer edge of the 500 year flood plain or higher based on topographical mapping. The USDA land resource regions handbook indicates that southwestern facing bluff properties such as this are unlikely to have permafrost and other gelic features. There are no signs of obligate or facultative wet vegetative species, although some facultative species do appear to be present. Aerial imagery does not provide any evidence of hydrology indicators anywhere on the site.
