(b)(1) non-adjacent wetland	1.34	acre(s)	(b)(1) Non-adjacent wetland.	The wetland is bounded by uplands on the east, south, and west sides. The wetland previously extended to the north where it coalesced into an unnamed tributary to the Cook Inlet. Construction of an authorized road severed the surface hydrological connection between the wetland and the tributary. The nearest culvert is not within the wetland and does not provide a surface connection between the wetland and the tributary. Construction of the road included sheet drains to allow hydrology to move across the road. Subsurface sheet flow does not provide the connection required under the NWPR.
