A large connected wetland is located east of the subject wetland. LiDAR and contour mapping indicate a slight ridge runs between the subject wetland and the large wetland. The change in elevation was observed during a site visit. As the land slopes upward away from the subject wetland, the vegetation shifts from a OBL/FACW vegetative community to a FAC/FACU vegetative community.
