# **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

This determination applies to a property located at 2301 & 2341 South Kaye Marie Drive, consisting of lots 17 & 18, in Block 3 of Mountain View Estates III Subdivision, located within Section 17, T. 02 N., R. 17 E., Seward Meridian; Matanuska-Susitna Borough; near Palmer, Alaska.

The AJD Requester provided aerial images of the property, spanning the years 1977 - 1985. Based on our review of the aerial images and other data referenced in Section IV, we concur with the Requester's aerial image interpretation that:

- 1. The images confirm that prior to 1984, lots 17 & 18 were an upland hayfield that was free of water or landscape depression any sort;
- 2. The image from 1984 shows that the water feature was artificially created in uplands incidental to gravel extraction for adjacent dike construction extending south into the Matanuska River.

Therefore, we conclude the water feature is a water-filled depression that resulted from excavation in upland for the purpose of obtaining fill material, which meets the criteria contained in paragraph 33 CFR 328.3(b)(9), and determine the water feature is not a water of the United States.
