


Figure 4. Plan View of Barge Landing site to be excavated adjacent to Stuart Is. rock quarry.





Figure 3 Elevation View of Cross-Section of Barge Landing Excavation on southeast corner of Stuart Island adjacent to proposed rock quarry.

Begin at the Community of Stebbins, travel by water or air north westerly 2.5 miles across Stephens Pass to the Stuart Island Quarry location on the south east shore of Stuart Island.

18. Nature of Activity (Description of project, include all features)

Activities will be those of a rock quarry and barge landing on Stuart Island, where Stebbins Rock Products, a subsidiary of Stebbins Native Corporation, will produce and export rock products, specifically high quality armor rock. The features of the these activities will be:

- 1. Prepare a temporary barge landing for mobilization of heavy equipment to quarry site;
- 2. Drill, blast, sort, screen and crush rock as necessary to make rock products, specifically high quality armor rock;
- 3. Transport, stockpile and store rock products as may be necessary;
- 4. load rocks to barges over temporary ramp to be removed on job completion;
- 5. Heavy Equipment to be used: Cat 345 & 320 excavators, Cat D9H dozer, Terex T40 and Volvo A25B rock trucks, Volvo L120 and John Deere 644 loaders, additional equipment, screen plant, crusher as jobs may require.

19. Project Purpose (Describe the reason or purpose of the project, see instructions)

The project purpose is to provide rock products for Bering Sea projects, where there is an ongoing need for durable armor rock. Tests indicate a substantial resource of easily accessible high quality armor rock is available on property owned by SNC/SRP on Stuart Island. The quarry was permitted through 2013, though not utilized. Now with a successful operating arm, opening Stuart Island will make it possible for SRP to expand, grow and be more competitive.

The Stuart Island Quarry will provide jobs and economic opportunity to members of the Stebbins Community, SRP shareholders and the Bering Sea community at large. SRP subsidiary Tapraq LLC, in its third year of operations, currently operates the Stephens Hill Quarry. The expansion to Stuart Island is a part of SRP's Development Plan.
