POA-2008-616, Taiya River	The Taiya River is about 17 miles long and drains about 180 square miles. The river is subject to the ebb and flow of the tide to a point just below the Taiya River bridge, and therefore, is a Traditional navigable water (TNW). The river is also navigable in fact. The Taiya River is an anadromous water body and is within approximately 1,000 - 1,500 feet from the proposed project location. The Taiya Rive supports federally managed fisheries resources (i.e., King and Coho Salmon, Eulachon and Dolly Varden trout). Interstate and foreign travelers harvest trout and salmon while engaging in sport fishing in Skagway. Fish that outmigrate from and in-migrate to the Taiya River and its tributaries (e.g., West Creek) are also caught by commercial fishers in Tiaya Inlet and other nearby navigable waters (i.e., Lynn Canal). Also, the Taiya River was used in the past to transport interstate and foreign commerce in support of gold mining activities, and is presently used by commercial guides, via boat, for wildlife viewing, fishing, hunting, and kayaking. The proposed project location is a side channel to the Taiya River located on the east side of the Taiya River valley running from the Taiya River bridge to a culvert under the road, which is now the channel's only surface connection with the river. The channel is approximately 3,000 feet long and origially was an overflow channel of the river, but was diked off from the river's main stem to the north about 50 years ago. Similar to oxbow and braided stream channels, which are treated as part of the same order tributary, the channel, therefore, is part of the Taiya River. Additionally, the site includes approximately 0.1 acres of palustrine wetlands. These wetlands meet the regulatory definition of wetlands and they are not isolated wetlands. These wetlands are jurisdictional waters of the United States because they directly about the Taiya River, which is a TNW and a relatively permanent water.
