Aug 13, 2021 Draft Minutes.

1. Opening remarks

- a. Rena thanked Jay for setting up the room, Denise for working with Jay, Ginny for taking notes
- b. Roll Call/Quorum
 - i. Present, Jay King, Denise Rankin, Elise Contreras, Alyssa McDonald, Virginia Hatfield, Rena Flint
 - ii. Absent: James Paulin, Patty Gregory, Dave Gregory, and Kale Bruner

2. Revise/Adopt minutes

- a. Ginny moved to adopt minutes from June 28, 2021, and Jay seconded

5. Unalaska Valley

- a. Potential Institutional Controls

- i. **UST 2664 (ADEC Hazard ID: 2878)** currently used as industrial site (C&G, LLC yard at the corner of East Broadway Ave and Whittern Lane across from DPW). Levels exceed ingestion levels but not inhalation. Rena asked the board to consider the risk of ingestion. *Levels exceed migration and groundwater*. Rena suggested this is a candidate for Institutional Controls. Dennis asked if the foundation that is still in place would continue to stay in place. Rena mentioned the area is currently used and the foundation is use as a lay down area. Alyssa noted the last water sample was in 2000 and could we have new water samples? Rena stated it was not prohibitive to take more samples, but ID-ed they didn't exceed then, it is unlikely to now. Denise asked if this was a place with underground storage tank, Rena confirmed. Dennis said they could sample the well again for Institutional Controls. Alyssa asked where the samples were taken. There was discussion about which water wells were used then and may have been destroyed. Two wells labeled #1 were noted to still be present and a well #2. Karen asked if there were sensitive community activities in the areas, such as playgrounds, etc. Denise noted there were apartments nearby. Thomas noted the distances to the wells and to the apartments. And he mentioned there were no current plans for development of apartments along Whittern Lane. The board

members noted the proximity of fish habitat. Dennis suggested resampling from both Well WP-1s. Cas asked for updated coordinate locations for the sites and Rena noted they were all off and would get updated coordinates for the locations. **Rena recommended the path forward for this site would be to sample the ground water at both MW1s and MW2 (find or replace) and see if Institutional Controls will be effective.**

- ii. **UST 2667 (Hazard ID 2876)** Currently used for the Department of Public Works (1035 East Broadway Ave) and is capped by the building, preventing groundwater infiltration through soil and therefore eliminating migration to groundwater pathway (no groundwater contamination). DRO in soil not exceeding Inhalation or Ingestion levels. Dennis- Candidate for Institutional Controls, Karen asked what would happen with change in owner and removal of building. Cas noted the Institutional Controls is a process. Dennis mentioned they would put Environmental Covenant in place to inform all future landowners about contamination. **Rena will work with City Manager to develop the environmental covenant. Path forward then is to put in place the Institutional Controls and work with the city manager.**
- iii. **UST 2674 (ADEC Hazard ID 2880)** foundation across East Broadway Ave from 1398 East Broadway Ave. Rena noted this might be a could candidate for soil removal and resampling. Thomas noted that the current land owner is building a structure to house equipment related to fuel oil storage (trucks, infrastructure). Also 400 feet away from municipal well. Cas thought it would be good to resample and might be able to close without Institutional Controls. Asked how deep to groundwater. Rena said it was deeper than they sampled – greater than 4 (feet?). Thomas said site is elevated and foundation not planned for removal. Alyssa asked how intrusive is the sampling drill rig. Rena described TWP installation. Thomas asked about the impact to the structure. Rena thought it would not be intrusive. **Plan going forward suggested resample the groundwater (via temporary well point) and close site without Institutional Control.**

b. Potential Resample *or removal action*:

- i. **UST 3260 (ADEC Hazard ID 2890).** Rena noted this site is a candidate for resampling or removal. It is located up in Ski Bowl. Owned by the City and was a former mess hall with underground storage tank and latrine. Levels exceed cleanup levels so we should consider soil removal. Shallow groundwater in the area. Thomas asked who was responsible for cleanup. Rena confirmed it was USACE. Dennis asked about the extent of contamination and whether it was delineated. Rena and Dennis discussed the vertical and horizontal extent. It is unclear if it went to groundwater. Rena mentioned she needed to consult the project engineer. Dennis

suggested monitoring and revaluation. Dennis asked about low groundwater season. Denise stated late summer, also this is an ANCSA-conveyed recreation area. **Rena restated the path forward then was soil removal and monitor of trends in groundwater.**

- c. To Be Determined: *potential resample or Institutional controls*
 - i. **UST 2267 AB (ADEC Hazard ID 2879)** residence located on Lear Road. Rena noted this site is in fractured bedrock, very little soil to be sampled at the time. Levels do not exceed Inhalation or ingestion. Rena asked about the feasibility of soil or groundwater sampling or feasibility removing soil. Denise noted there were a lot of houses in the area and it may be hard to remove, ID house and landowner thoughts. Rena agreed. **Dennis noted that if it is on fractured bedrock perhaps we do a historical review and demonstrate it is on bedrock and close the site as de-minimus without Institutional controls.**
 - d. Ginny reviewed the list of recommendations. Alyssa moved to adopt the proposal, and Jay seconded, that the board would recommend the following:
 - i. UST 2664 be sampled the groundwater and see if Institutional Controls are appropriate
 - ii. UST 2667 put in place Institutional Controls and Rena will work with the City Manager.
 - iii. UST 2674 sample the groundwater and close without Institutional Controls
 - iv. UST 3260 remove soils and monitor groundwater for trend
 - v. UST 2267 AB to figure out the bedrock and groundwater situation (conduct historical review, get information and establish groundwater and bedrock situation and consult the landowner about de-minimus and no Institutional Controls)
