1. Welcome and Introductions
  - a. Rena kicked off the meeting with opening remarks and started recording the meeting for note taking purposes.
  - b. Roll call conducted.
    - i. With five (5) there is a quorum.
  - c. Meeting Goals and Objectives
    - i. Rena reviewed the agenda.
2. Revise/Adopt August 2, 2023 Minutes
  - a. Rena asked for a motion to Revise/Adopt August 2, 2023 Minutes
  - b. Alyssa motioned to adopt minutes from August 2, 2023. Elise seconded the motion to adopt minutes from August 2, 2023.
  - c. Rena also stated that those meeting minutes were provided in the meeting materials as well as posted on the U. S. Army Corps of Engineers public website.

**Decision: Adopt August 2, 2023 minutes as written.**

3. Local Updates/Community Introductions/Public Comment
  - a. Rena requested Thomas to facilitate any kind of introduction for those in the room.
  - b. Thomas also asked for anyone in the room to sign in. There were no introductions.
  - c. Rena asked for anyone on the phone or virtually to come off mute that wanted to.
    - i. Karen Pletnikoff with the Aleutian Pribilof Islands Association (APIA) thanked the RAB for being so active and for covering sites past Unalaska Island and for getting so much accomplished. Karen also stated that APIA is interested in two things that came out of the environmental justice listening session with the Department of Energy and some other participants, including USACE. She thanked the USACE team for bringing leadership to listen. First, they note that it has been since 2004 since the region has made a formerly used defense sites (FUDS) priority list. They think it's a good time to consider revisiting that list, to see what progress has been made on those sites and talk about whether or not it is time to offer a new set of priority sites or to potentially even prioritize if that was what the body wanted. Separately, they are interested in following up in partnership with the Aleut corporation on greater environmental justice initiative for the region that has been so impacted by activities. The environmental justice throughout the region is something that they're interested in and doesn't have a direct funding source at this time, but it would certainly be something that we could work on through EPA gap programs and search for other funds.
    - ii. Mandy Salimen introduced herself as the Environmental Program Director the Qawalangin Tribe of Unalaska.
    - iii. Ken Andraschko introduced himself as the contaminated ANCSA sites coordinator for the EPA. Ken will add his contact info to the chat for anyone with question about the program (see below).
    - iv. Richard Ragle introduced himself as the FUDS program manager for Ugadaga Bay

- v. Cas, DEC project manager for sites in Unalaska, introduced herself and gave props to the City and Ounalashka Corporation for all of the hard work to get cleanup funding to cleanup sites.
  - vi. Natasha Albee introduced herself as a new Qawalangin Tribe employee.
4. City of Unalaska Brownfields Advisory Board Update
- a. Thomas Roufos gave the announcement that they have approval of the Quality Assurance Project Plan (QAPP) as of today. He also briefed that they recently had a productive meeting with Qawalangin Tribe about Unalaska Lake, and they are hoping to collaborate to survey the lake.
  - b. Doug Quist, chemist and environmental scientist over at Stantec, gave an update including details on programmatic QAPP approval, area-wide Regulated Building Survey Program, eligibility determinations (EDs) within the Brownfields Program were completed for Strawberry Hill and for Pyramid Valley, and finalizing web based inventory of all of the digitized features.
  - c. Alyssa asked how many quonset huts in town are being utilized? Doug stated that it's not just limited to Quonset huts. Quonset huts and cabanas are included in the inventory that is being developed. Alyssa also asked if the city will be in contact with the owners? Some are inhabited and she wondered if they will be tested for issues that may be present. Thomas answered that the City Planning Department will be doing the outreach for that. The testing will be voluntary to the owners, and renters would have to ask property owners for permission. Alyssa asked if the property owners will have some sort of help in mitigating that damage? Thomas answered that the goal is to use the survey research to apply for other funding and timeframe will depend on funding.
  - d. Theo also asked about the Light Detection and Ranging (Lidar) and what the next steps are after that, specifically timeline wise. Thomas answered hopefully, sometime next summer to be flying the drone and doing the bathymetry. The goal is to work with the Tribe's program to utilize their money for mobilization and possibly combine projects and programs with similar scopes.
  - e. Rena also said that the Amaknak FUDS has a Lidar need in the future for the Military Munitions Response Program (MMRP) remedial investigation, so perhaps we could try to sync the programs. Thomas asked Rena to follow up with what area FUDS is planning to looking at. Rena indicated Amaknak Island would be the initial focus.
  - f. Doug added that there was some talk about potentially including an infrared survey. They've had great success using infrared and Lidar in combination in the past for identifying sites, temperature gradients, seeps, preferential pathways for contamination, and identifying potential locations for sampling and or remediation.

**Action item: Rena will follow up with Thomas about the area Amaknak FUDS has planned for Lidar.**

5. Alaska Public Media Video about the Unalaska Valley Cleanup
- a. Theo Greenly (KUCB and channel 8 TV) has been doing stories on FUDS program in general and Amaknak FUDS the last few years. Alaska Public Media, specifically the show Alaska Insight, reached out to collaborate on a story about primarily the Ski Bowl site (Amaknak FUDS Unalaska Valley UST 3260). It is going to be about four and a half minutes long segment which goes into a panel discussion. Rena may be a panel guest for the

discussion. The release of the story has been pushed back to an upcoming Friday, possibly 17 November.

- b. Rena added that at the Unalaska Valley Ski Bowl site the excavation was completed, super sacks of contaminated soil were transported to the disposal facility and the fieldwork is complete.
- c. Ben asked if Theo could track the release date of the Alaska Public Media segment and send an update. Theo answered that it will air locally and will be posted on the KUCB website. He will also send a link out the RAB email list when it is available.
- d. Theo also asked what the status was on the rest of the Unalaska Valley sites. Rena stated that they will make a final recommendation in the report for decommissioning of a handful of monitoring wells, and if approved, they will come back out and do monitoring well decommissioning sometime in 2024.

**Action item: Theo will email a link to the story to the RAB/email list when it is available.**

- 6. Rena motioned to take a five-minute break from 1843 to 1848.
- 7. Fiscal Year 2024 (FY24) Look Ahead Chernofski Harbor Supply and Storage Site FUDS
  - a. Wendy Hansen (technical lead and acting project manager) gave a presentation that included:
    - i. Vicinity map showing location of Chernofski Harbor, particularly relative to Dutch Harbor.
    - ii. A brief recap of the 2022 field work and presentation that occurred during the May 2023 RAB meeting. This included a map of various locations visited during the field effort, a big picture overview that five batteries, three tanks, thirteen drum remnants, 3,200 tons of contaminated soil (largely petroleum), and 1,200 feet of fuel pipeline were removed across the Chernofski Harbor projects in 2022. In addition, a large investigative effort took place that included inspecting WWII building footprints for the presence of batteries and collecting soil samples, installation of approximately 260 screening probes, 200 soil borings and thirty-seven groundwater monitoring wells, and the collection of sediment and porewater samples at tank sites. It was also announced that the after-action report for these activities and a newly drafted Community Relations Plan will soon be sent to the Unalaska library where the documents will be available for public viewing.
    - iii. An update on Containerized Hazardous, Toxic and Radioactive Waste (CON/HTRW) projects (i.e., drums; tanks; batteries): a) Investigation and removal of paint cans and batteries across Chernofski Harbor is complete. b) A Decision Document is now required and planned to address petroleum contamination that remains. The project team will request funding once we have worked through that process and approval is obtained. Field work might occur as early as fiscal year 2025 or 2026.
    - iv. Future planning includes a Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) Remedial Investigation/ Feasibility Study (RI/FS) to address non-petroleum contamination at Chernofski Harbor.
    - v. An Archaeological Update (high level):
      - a) USACE lead archaeologist Kelly Eldridge is tracking progress for the Memorandum of Agreement (MOA) deliverables.
      - b) Old Chernofski Village Report was finalized in March of 2022. Stakeholders were

provided hardcopies in March of 2023. The distribution list included the Alaska State Library and Museum of the Aleutians where the public should be able to access the document.

- c) A draft of the Chernofski Harbor World War II District Historical Report was sent to stakeholders via DoD SAFE 12 October 2023. USACE has requested comments by 24 November 2023 and anticipates finalizing the document by 31 December 2023. If parties to the MOA do not have the document and would like a copy, please let Wendy Hansen or Kelly Eldridge know so a new link for download can be provided.
  - d) A draft report for UNL-160 is in progress.
  - e) Artifacts Update: Artifacts excavated in 2019 are at the Museum of Aleutians. Those removed in 2022 are at USACE in Anchorage for analysis and will be accessioned to the Museum of Aleutians.
8. FY24 Look Ahead Fort Learnard FUDS
- a. Jeremy Craner gave a quick update on the MMRP project at Fort Learnard FUDS.
  - b. USACE will continue to provide documents for review as they work through the Comprehensive Environmental Response Compensation and Liability Act (CERCLA) cleanup process.
  - c. Next Systematic Project Planning (SPP) and community meetings are planned for May 2024.
9. FY24/25/26 Look Ahead Ugadaga Bay Station FUDS
- a. Richard Ragle introduced himself and gave a brief overview of Ugadaga Bay including background and where the project is in the CERCLA process.
  - b. Natalie Cale (OC) asked why there was so much lag time between Preliminary Assessment/ Site Inspection (PA/SI) and RI.
  - c. Richard answered that there are limited resources and energy was focused on sites within populated areas of the island.
  - d. Rena added that there was also a right-of-entry issue due to a landowner lease in 2019 and limited ability to narrow the project scope at that time that added to the delay.
10. FY24 Look Ahead Cape Wislow AWS Station FUDS
- a. Forrest Kranda gave a brief look ahead at what is planned for 2024 including a site background, pending results, and reporting.
11. FY24 Look Ahead Amaknak FUDS
- a. Rena Flint gave an overview on each of the eleven (11) projects in Amaknak FUDS.
12. RAB Membership Changes/ Recruitment
- a. Denise Rankin has resigned from the RAB as of October 1, 2023.
  - b. Thomas Rufous has volunteered to join the RAB and will be submitting an application. He suggested that some of the regular meeting attendees apply to be on the RAB. It may also be a good idea to reach out to RAB members that have not been participating and see if they would have someone in mind to take over their responsibilities.
  - c. Alyssa has been working on potential recruitment and can make a PSA announcement on

**1. Welcome and Introductions**

- a. Moderator Denise Rankin kicked off the meeting with opening remarks and started recording the meeting for note taking purposes.
- b. Roll call conducted.
  - i. 3 members present. There is no quorum.
  - ii. Members agreed to induct Ellis Berry as a Board member without quorum present as it was already agreed to via email.
- c. Meeting Goals and Objectives
  - i. Denise gave an overview of the purpose of the RAB Meeting and introduced OCE as the USACE contractor facilitating the RAB Meetings for USACE.
  - ii. Rena reviewed the agenda.

**2. Revise/Adopt November Minutes**

- i. Without a quorum, the Board will have to adopt November 2023 and February 2024 minutes at the May 2024 meeting.

**Action Item:** Add approval of minutes for November and February meetings to the May 2024 agenda.

**3. March 1, 2023 RAB Operating Procedures**

- i. Rena introduced the topic for an open discussion on meeting frequency. Comments were made that indicated that quarterly meetings were not enough and were packed with a lot of information that more frequent meetings would be better. Rena requests feedback.
- ii. Denise suggested having more meetings or breaking the quarterly meetings up with fewer presentations for more in depth discussions with each of the sites in the RAB. Denise also mentioned the set up of the room in a roundtable style instead of the Council Chambers was very nice and hoped it would promote more free discussion. Denise stated she felt less nervous sitting and talking rather than in front of a mic. Denise opened the discussion to the RAB Board Members on meeting frequency.
- iii. Laresa proposed inviting more non-profit organizations to the meetings to see if they have anything to contribute or learn more. She listed Unalaskans Against Sexual Assault and Family Violence, Museum, Wellness Center, Clinic, Ginny suggested the Visitors Bureau. Denise proposed that maybe we reach out to the High School History class.
- iv. Ben concerned about people's time restrictions that maybe shorter meetings better.
- v. Rufina, an elder in the community stated she didn't know much about the RAB meetings but saw the poster and wanted to learn more. She suggests that they encourage younger people to come. She also talked about the Senior Center Denise suggests reaching out to the High School.
- vi. Elise suggests a hybrid of meetings including the quarterly meetings but have some smaller informal discussion on certain projects.
- vii. Rena stated that monthly meetings in the past were hard to do. Suggests every six weeks.
- viii. Ben believes this meeting is for community and how much they can participate needed for input.

**4. Local Updates/Community Introductions/Public Comment**

- i. Rena formally recognized and inducted Ellis Berry as a new RAB Board Member.
- ii. Rena invited anyone interested in the being a member of the RAB Board to contact her to receive an application. Suggests Thomas apply.
- iii. Rena introduced Taylor Borgfeldt as the new Project Manager and Co-chair of the RAB. Taylor introduces herself and is excited to work on the RAB and with the group. Melissa Scully introduced herself as the technical lead for the Amaknak FUDS Property.
- iv. Karen Pletnikoff with Aleutian Pribilof Island Association (APIA) introduced herself. She stated she is not a board member but makes most board meetings to stay up to date for APIA of what is going on in the region and advocate for sites that do not have a nearby tribe.
- v. Natalie Cale asked if Rena could explain what the RAB Board member position entails to help people decide if they would like to become a board member. Rena replied that she could send out the membership form along with the Operating Procedures. Attendance and participation in meetings and advising remedies of cleanup of FUDS. The position will also review documents, as much or as little as you want, but number one is being there and speaking at the meetings. Elise added it was a great way to stay informed and involved with the FUDS cleanup. Ben added that it is important to know what is being cleaned up and advise on areas that hold more weight. Rena added another aspect is being a conduit to the community to give information.
- vi. Sean O'Donnell was introduced as the new tribal liaison for the Army Corps of Engineers, Alaska District. He is new to the job and is just learning at all the advisory meetings he attends throughout the state. His job is to help answer questions and navigate program areas to be a better resource in the community.
- vii. Cas Galasso of ADEC announced her transition out of her role, and introduced Sarah Bernhardt, who will be taking over on the active contaminated sites in the area.
- viii. Donna Van Flein mentioned that there are comment cards for those not comfortable asking questions to the group. They will be read and addressed later in the meeting.
- ix. Natalie Cale states that she is encouraged that cleanup has become not only a community issue, but USACE, EPA and Sen. Murkowski priority. The Tribe, City, OC, ADEC, USACE are working together to get a game plan to focus on areas to cleanup in an organized way. Creating a bigger picture for cleanup efforts. The community may add their priority, housing, recreation, etc. Natalie brought attention to all the funding that is available, especially the grants. She pointed out how all parties with grants are meeting so that everyone can put the money to good use on the island to get the areas cleaned up.
- x. Jeff Estes with EPA is interested in what the greater community's interests are to maximize the funds that EPA has to offer. He is also available for questions for anyone who needs help.
- xi. Marc Hansmeier is an engineer with Ahtna and is new to the RAB meeting.
- xii. Sarah Bernhardt with Alaska DEC is looking forward to working with everyone. Agreed that she will miss Cas at ADEC, but we will do our best to fill her shoes, and that her email is [sarah.bernhardt@alaska.gov](mailto:sarah.bernhardt@alaska.gov) if anyone needed to contact her.
- xiii. Ken Andraschko is the EPA contaminated ANCSA Lands Program Coordinator. He pointed out all the funds that are available, like the Community Change Grants. He said

please reach out if you need help and he will help find opportunities for the community.

- xiv. Karen Pletnikoff wanted to point out that along with all the other grants available there is also the Environmental Justice fund available as well. These could be sites impacted by climate change.
- xv. Thomas Roufos added Fire fighters local chapter would be another non-profit organization to invite to the RAB meetings.

**5. City of Unalaska Brownfields Advisory Board Update**

- a. Thomas Roufos is the Associate Planner for the City of Unalaska. He is giving the Assessment Grant update. They have finished Phase 1 of site visits, and that report should be available to the community in a month or two. Strawberry Hill is the first to be completed, then Pyramid Valley. All of this will be available on the City's website on a brownfields page under the planning section. He also mentioned they should have for the next meeting an inventory of sites and resources in the community and brownfields areas of interest. The city is working on the portal and dashboard so the community can access it. Thomas concurred that it is beneficial having this Brownfields group to work together and not duplicate efforts. The creation of the site inventory portal for the community will be beneficial for viewing the information of what all that is going on and what area it is happening in.
- b. Thomas spoke about the coordination meetings with OC, the consultants, Q Tribe, and USACE to coordinate cleanup in Unalaska. It helps to share information to better use the resources granted. Thomas stated it was an exciting opportunity to work together. He will report an update next meeting. Thomas discussed the city's area of focus on Strawberry Hill and Pyramid Valley. They will be doing a Lidar study of the areas as well as a bathymetry survey for Unalaska Lake and the lake on Standard Oil Hill, which they are working with the Tribe. They will announce a voluntary program for Cabana owners. They have received EPA approval to look for restricted building materials, like asbestos, lead paint and mold in the buildings. It will be more focused on the World War II era housing. This will give more information to get an additional grant to clean it up. Thomas announced that OC will be looking at a cleanup of the asbestos landfills on Strawberry Hill and outside Building 551 cleaning up PCBs.
- c. Natalie shared that OC was one of three recipients of the EPA ANCSA contaminated lands cleanup grant. Building 551 will be the site of that cleanup and will begin this spring. OC is working closely with Jeff Estes of EPA on this grant.
- d. Elise added that the Tribe is working on debris removal in Unalaska Valley and Pyramid Valley this summer.
- e. Cas questioned where the focus on Strawberry Hill will be, as there are tar ponds on the Strawberry Hill site. Thomas outlined the area from Tony's to before the two tanks, and out to the lake and avoid Rocky Point Management Area and tar ponds.

**7. Chernofski Harbor Supply and Storage Site FUDS Archaeology Update**

- a. Kelly Eldridge, senior archaeologist at US Army Corps of Engineers, Alaska District provided a report on the Chernofski Harbor Supply and Storage Site.
- b. Wendy Hansen, technical lead and Interim Project Manager for FUDS, USACE did removal actions and investigations. Last action was in 2022, but they were out there in 2017 and 2019. In 2022 USACE removed about 3,000 tons of petroleum contaminated soil.
- c. Kelly spoke about the cultural resources work under an MOA in 2018 with the various

stakeholders. SHPO, Q Tribe, St. Paul, TDX, the Russian Diocese, OC, and the Aleut Corp. TDX is the largest landowner. Kelly discussed the way that things should be approached due to the historical factors. As cleanup work is underway, they need to treat and approach the very extensive and ancient, culturally dense area for preservation of WWII history and the Unangan history in the Chernofski area. She has really enjoyed working there. She outlined the list of tasks that they own their shareholders. There will be an archaeological monitor on site. Evaluate archaeological sites for NHP. Conduct the excavation in 2022. Also need to conduct an excavation at UNL0034. It is an ancient and historical site right next to the WWII site.

- d. Kelly stated they are required to create a place-based curriculum document. They evaluated three WWII features; the old mess hall, garage, and tank farm. And performed an in-depth historical investigation on the WWII area based on archival records. They just finished this three weeks ago. Kelly dropped off the new Chernofski reports at the library.
- e. Kelly spoke about the significance of the recovery of over 23,000 stone tools and 432 osseo artifacts made of bone or ivory. Many of these artifacts were the first to be excavated from such site in the Aleutians. The Museum of the Aleutians is the repository for these artifacts.
- f. The Chernofski site was an active site until 1920's.
- g. Kelly discussed the CRC conducting an excavation at the Chernofski Village Site (UNL-00034). Within five weeks they excavated ten square meters. Seven fragments of charcoal were collected for C14 analysis in 2019. In 2022 seven additional fragments of charcoal were collected for C14 analysis.
- h. The older dates for UNL-00034 date back 3,000 years. They recovered 23,211 lithic artifacts, 432 osseous artifacts and 560 historical artifacts. And 9,293 animal skeletal elements were analyzed.
- i. In 2022 at UNL-00160, there was one square meter that was excavated at a depth of 1.3 meters where six fragments of charcoal were collected for C14 analysis. 3,658 lithic artifacts, 2 historical artifacts and 11 degraded faunal remains were found. Kelly explained the challenges faced in collecting data from a site disturbed by a military mess hall during World War II.
- j. Kelly also revealed findings from an older site that dated back between 4,000 and 5,000 years ago and a World War II site, primarily an army installation supporting Fort Glen. This village site is behind the slaughterhouse. Some animal bones were still there. Birds, fish, and one seal element.
- k. At the UNL-00235 World War II site, USACE contracted AECOM to conduct archival research at NARA facilities, Kelly said hopefully they will have those reports soon.
- l. Laresa asked about whether walrus items were found and if any other animal bones were found as well. Kelly said there were walrus, polar bear, ring seals and whales there. There were structural whale bones in Chernofski village site.
- m. Rufina asked if they had found anything from another country from 1600's to 1700's. Kelly explained that a Japanese coin was dated from Chernofski, and it looked to predate the arrival of Russians. It was briefly mentioned in his monitoring report that was recently added to the library in Unalaska. In the 1800's there were other countries artifacts found. Rufina also asked about beads. But unfortunately, none have been found as of today.

- a. Melissa Scully, Environmental Engineer for USACE Alaska District, tech lead for Amaknak project team and interim PM last few months.
  - i. USACE awarded a contract to OCE to complete a removal action in Summer Bay-Humpy Cove and Little South America.
  - ii. A brief overview of the 2024 summer plans. Humpy Cove is the first site to be worked on. Was part of Ft. Brumback and contained tactical artillery, troop housing, mess hall, latrines, power generation and utility systems. 1998 UST and 540 tons of contaminated soil removed. Plan to remove DRO soil contamination. Excavate soil below groundwater. We will perform removal action, install, develop, and sample on temporary well, then install, develop and sample two temporary wells downgradient to see if any contamination migrated. Then decommission the wells then restore the area.
  - iii. The Little South America area includes a latrine site. This summer we are hoping to remove any DRO and determine if any of the contamination has migrated off the site. Removal action, install and develop some wells then restore the area. The second site in LSA was a mess hall, in prior removal action there was no fuel was noted in the tank but there was a fuel odor. This summer we hope to determine whether the residual DRO soil contamination is impacting the groundwater in this area. Plan to drill monitoring wells and decommission if impacting the groundwater.
  - iv. Ellis asked if the residual contamination to bedrock may affect subsistence? Melissa said she could look at the CSM and get back with him on that. Rena also said she would have to get back with him.
  - v. Rena asked specifically what subsistence the community is interested in knowing about. They are worried about the berries and mushrooms. Laresa also said the medicinal plants.

**Action Item:** Laresa to email list of medicinal plants to Rena for assessment of contaminant pathway risk.

- vi. Melissa gives a brief project schedule. Final Work Plan should be completed in March. A site visit in April, mobilization in June, Humpy Cove power plant, site prep, excavation, well installation in June through July, LSA building 1154 well install in late July, then monitoring well decommission in September. Then Reporting. January 2025 will have a draft report.
- vii. Kelly asked if there would be an archaeological monitor on site.
- viii. Melissa answered that there will be archaeological monitors on site at Little South America sites.

**Action Item:** Rena/Taylor/Mel to consult risk assessor regarding the potential pathway of contamination to medicinal plants, mushrooms and berries for remaining contamination at LSA site. Rena/Taylor to provide response to Ellis, Laresa, and at next RAB regarding LSA site concentrations, depths, and potential for diesel uptake by berries, mushrooms, or medicinal plants.

### 9. Fort Learnard FUDS update

- a. Forrest Kranda, Archaeologist for FUDS. Presented about Eider Point which was a coastal artillery defense site. There are residual munitions in two areas on that site.
- b. An archaeological survey was done in 2023 to evaluate Fort Learnard. It was found to be

eligible for listing in the National Register of Historic Places and contributing to the national landmark of the Naval Operating Base.

- c. Future remediation of munitions field work will include Cultural Resources Monitoring Plan, onsite archaeological monitoring, avoidance of ancestral sites and return the WWII features to their pre-activity conditions to degree possible.
- d. Field work start date is anticipated for April. There is a Systematic Project Planning meeting planned for May 2024, followed by the Public Meeting.
- e. Kelly asked if the meetings. The SPP meeting will be technical including ADEC and SHPO, but there will also be a general public meeting.
- f. Question about CERCLA. Comprehensive Environmental Response, Compensation, and Liability Act authorizes response to releases or threatened releases of hazardous substances into the environment. Forrest explained that most remedial plans and munitions removal must go through the process.
- g. Thomas asked what areas might not be safe to recreate. Forrest showed an Armco hut to where there would be munitions. There is one on the beach as well. Warned to watch where you step as there are things still on the ground. Coastal artillery rounds used were both 6-inch and 20mm ammunition.

**10. Review Next Meeting Dates/ Identify Next Steps**

- a. Next RAB meeting - May 15, 22 or 29<sup>th</sup> (Wednesdays)
  - i. Elise stated her preference is the 15 or 29.
  - ii. Ben stated all dates could work for him.
  - iii. Kelly advised that the Tribe has cultural nights on Wednesdays and Taylor is taking classes on Wednesdays. Kelly said Tribe recommended Mondays. Ellis said Mondays are good. Will send May 13, 15, 20 or 29 to RAB members. (May 27<sup>th</sup> Memorial Day)

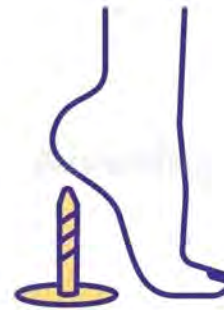

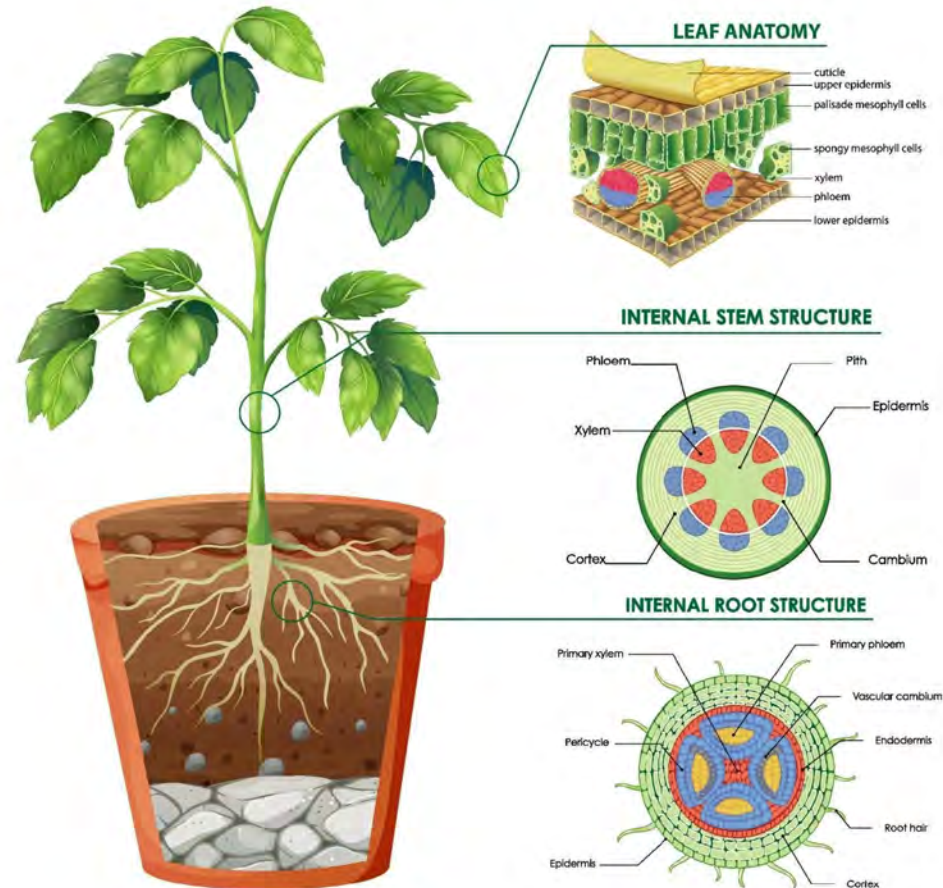
