Section 22 Planning Assistance to States and Tribes Program

Scope and Authority

Section 22 of the Water Resources Development Act (WRDA) of 1974, as amended, provides authority for the Corps of Engineers to assist the States, local governments, and other non-Federal entities in the preparation of comprehensive plans for the development, utilization, and conservation of water and related land resources.

Section 208 of the 1992 WRDA amended the WRDA of 1974 to authorize the Corps to partner with Native American Tribes in addition to State and local governments.

Funding

The Planning Assistance to States (PAS) Program is funded annually by Congress. Federal allotments for each State or Tribe from the nation-wide appropriation are limited to \$2,000,000 annually, but typically are much less. Individual studies, of which there may be more than one per State or Tribe per year, generally cost \$25,000 to \$200,000. Although multi-year studies may be conducted, Federal funds for out-years are not guaranteed.

These studies are cost shared on a 50 percent Federal-50 percent non-Federal basis. Up to 100 percent of the non-Federal share may be provided by in-kind services.

Program Development

Needed planning assistance is determined by the individual States and Tribes. Every year, each State and Indian Tribe can provide the Corps of Engineers its request for studies under the program, and the Corps then accommodates as many studies as possible within the funding allotment. Typical studies are only planning level of detail; they do not include detailed design for project construction.

Studies generally involve the analysis of existing data for planning purposes using standard engineering techniques, although some data collection is often necessary. Most studies become the basis for State, Tribal or local planning decisions. To assist in expediting a request for Planning Assistance to States activities, a sample letter is included in this brochure.

Typical Studies

The program can encompass many types of studies dealing with water resource issues. Types of studies conducted in recent years under the program include the following:
