C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: A JD was conducted on July 3, 2019 with two data points collected at the site to establish the boundary of the wetland area. The entire area was walked to analyze changes in vegetation and elevation. Data point 1 on Lot 6 was determined to not be a waters of the US and data point 2 on 140th Avenue ROW was determined to be

jurisdictional waters of the US. Both data points were collected in undisturbed areas adjacent to areas that were altered by fill material prior to the site visit. The undisturbed areas were assumed to be representative of the altered areas based upon review of historical aerial photography.
