**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant**

nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The review area within the JDR was originally restricted to the upland areas of the site. The review area was enlarged to include the abutting wetlands so as to clearly identify the wetland/upland boundaries within the review area. The purpose of the delineation was to identify the area in which the landowner could discharge dredged/fill material without having to obtain a DA permit. Given that the majority of the region is wetland, the delineators focus was on identifying uplands not on identifying wetlands. It is as if there is the presumption that the area is wetlands until it can be shown to be uplands. Consequently, the majority of the data provided documents the presence of the upland islands in a sea of wetlands.
