- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The red lines are within the review areas as shown on the Figures 1 and 2 in Memorandum for Record (MFR) dated August 16, 2021. The National Wetlands Inventory do not indicate wetlands or stream channels in the review areas. The NRCS soil mapping indicates soils that are well drained, that don't pond or flood and do not have a hydric rating (Figure 3 MFR dated August 16, 2021). The few small drainages in the review areas are at the extreme upper slopes and are not mapped as streams in NWI. The review areas are on south and southeast facing steep slopes near the top of a ridge where upland land would be expected to be located. The locations of the review areas were sited by the proponent to avoid streams and wetlands.
