## **SECTION III: CWA ANALYSIS**

#### A. TNWs AND WETLANDS ADJACENT TO TNWs

#### 1. TNW

Identify TNW: Kongiganak River

Summarize rationale supporting determination: Kongiganak River is an approximately 40 mile river in the Bethel Census Area that drains into Kuskokwim Bay which is a part of the Bering Sea. The Village of Kongiganak is approximately 4.60 river miles from the bay and the river at this point is still subject to the ebb and flow of the tide.

#### 2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": According to 33 CFR § 328 DEFINITION OF WATERS OF THE UNITED STATES, the term adjacent applies when wetlands are bordering, contiguous, or neighboring, a jurisdictional water. The Kongiganak River is a jurisdictional water because it is a TNW. The wetlands in the review area are part of the contiguous network of wetlands that are adjacent to the Kongiganak River. The continuity of the wetlands can be detected in satellite imagery that shows the drainage patterns within the wetlands as discussed in the 1987 "Corps Wetland Delineation Manual".

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the

physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

## **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

According to the U.S. Fish and Wildlife Service's National Wetland Inventory mapper the entire review area is located in freshwater emergent wetlands. The habitat is classified as a PEM1/SS1B. Analyzing the satellite imagery available parts of the review area appear to hold surface water and be a part of the large continuous wetland area that is adjacent to the Kongiganak River. The drainage patterns within the wetlands as discussed in the 1987 "Corps Wetland Delineation Manual" support this determination. As a result, it is the conclusion of the Corps that the review area is composed entirely of jurisdictional wetlands.
