If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. Obligate skunk cabbage (*Lysichiton americanus*) is growing in the stream channel, which implies that the channel is saturated at a frequency and duration to support only obligate plant growth. Additionally, April – June are typically drier than the rest of the year, with April seeing 2.96 inches of precipitation on average. The presence of water in one of the driest months of the year indicates that, although frozen in winter, flow is continuous year-round. The tributary flows directly into the Mendenhall River, which is a TNW.



**B. ADDITIONAL COMMENTS TO SUPPORT JD:** One wetland and one stream were delineated on the May 6 site visit. Hydrophytic vegetation, hydric soil, and hydrologic indicators were observed on the parcel. Vegetation observed in the field passed the dominance test. Hydric soils within the parcel meet the Alaska Redox with 2.5Y Hue Indicator (a mineral layer starting within 12 in. of the soil surface with a dominant hue of 2.5Y with a chroma of 3 or less, with 10 percent or more distinct or prominent redox concentrations occurring as pore linings with a value and chroma of 4 or more). Surface water was present at the time of the site visit, and visible drainage patterns and reduced iron also indicate that the parcel consists partially of wetlands. The stream bisecting the property has continuous flow year-round and flows directly into the Mendenhall River, which is a TWN. Therefore, the subject parcel contains jurisdictional waters of the United States.
