**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The delineated project areas can be seen in the attached supplemental map and applicant supplied site photos. The project site contains historically mined, previously disturbed areas with coarse rocky substrate and southern facing convex slopes that are unlikely to have soils that contain permafrost to perch water. Aerial imagery



shows no signs of surface water or hydrology patterns within the project areas. The hillsides are also composed of what appears to be coarse substrate well drained surfaces. Stunted growth among vegetation can be explained by elevation rather than saturation. Based on the best available data, the project areas do not support the necessary factors that would indicate the presence of wetlands. Therefore, the subject project areas do not appear to contain waters of the U.S., including wetlands, under the Corps of Engineers (Corps) regulatory jurisdiction. Gold Dust Creek, an RPW, is a water of the U.S. (WOTUS) in the vicinity of the project that flows through the review area. Gold Dust Creek flows into Birch Creek which flows into the Yukon River, a Section 10 Navigable Waterway. No work would be conducted within Gold Dust Creek.
