C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Provide rationale indicating that wetland is directly abutting an RPW: A wetland delineation report was prepared by 3-Tier Alaska Civil Engineering & Surveying and Travis/Peterson Environmental Consulting. Fourteen (14) sample points were taken in June 2022 to identify the wetlands within the area to reconcile against the NWI. Eight (8) of these points had all 3 of the wetland indicators present and indicate two wetlands within the area of review. Both of these wetlands directly abut McRoberts Creek.



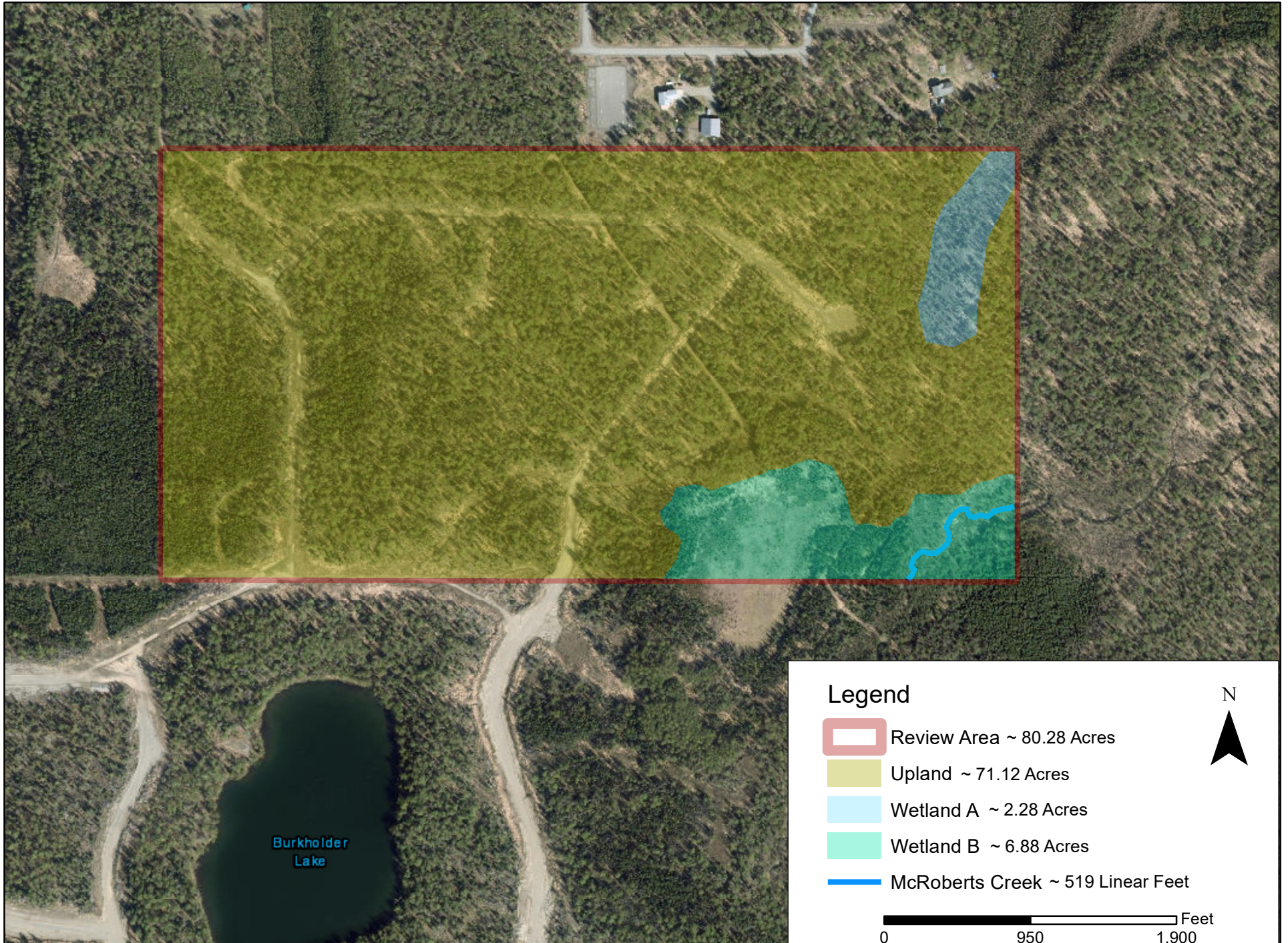

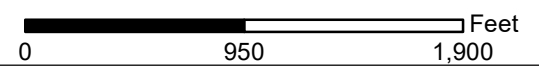
