MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),<sup>1</sup> POA-2017-00433, Yukon River, (MFR 1 of 1) as appropriate<sup>2</sup>.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

## 1. SUMMARY OF CONCLUSIONS.

- a. The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under the Rivers and Harbors Act of 1899 in the review area). Based on the best available information, we have determined that the review area consists of entirely dry land.

- ## 3. REVIEW AREA.
- The review area is approximately 0.33-acre parcel consisting of a homesite, deciduous vegetation and areas that have been cleared and graded. The review area is located at latitude 66.359688, longitude -147.403177 at the center of the review area, Section 30, Township 18N, Range 2E, USGS Map Quad Beaver B-

1, Beaver, Alaska. See the attached map. A previous Dryland AJD may have been completed in 2017. No signs of surface water including flow patterns are apparent within the review area across multiple years. Likewise, the National Hydrography Dataset (NHD) shows no surface water features within the review area. Vegetation communities on the property entail a forested area and two cleared areas that have varying levels of vegetation cover. The forested area appears to be comprised of primarily comprised by Alaska paper birch (*Betula neoalaskana*) and white spruce (*Picea glauca*), which are both commonly found in uplands. Given the information available, it is not possible to determine the vegetation likely growing in the cleared areas. Based on the best available information, there are no indications that wetlands are present within the review area.

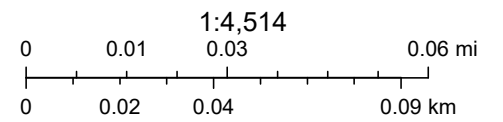
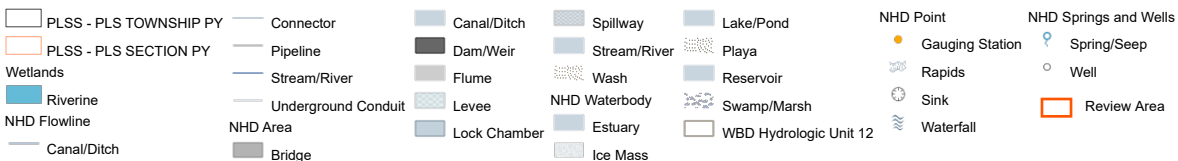
