MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ POA-2024-00232, MFR 1 of 1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

- 3. REVIEW AREA.

The delineated review area is 0.55 acre and can be seen in the attached supplemental map. It is located in Section 3, T. 7 N., R. 12 W., Fairbanks Meridian; Latitude 65.4580, Longitude -150.0069; near Rampart, Alaska.

The review area contains 0.43 acre of uplands and a 0.12-acre historical mining pond that was excavated entirely in dry land. The pond was created in uplands for use as a settling pond to treat wastewater during placer mining operations and will continue to be used as such. The pond has no inlet or outlet channels. Per 33 CFR 328.3(b)(5) artificial lakes or ponds created by excavating or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing are not waters of the United States. Therefore, the pond would not be considered a water of the United States. The project site is located on a well-drained alluvial bench on a south facing hillslope approximately 400 feet above the valley floor of Little Minook Creek. The area has been previously disturbed through historical mining. United States Department of Agriculture (USDA) soil data indicates the review area contains Interior Alaska Highlands-Boreal Upland and Alpine-Rugged Mountains (E31M9). E31M9 is not rated as hydric; it is described as well-drained, never flooded, and having a depth to the water table of more than 80 inches. No signs of surface water including flow patterns are apparent within the review area across multiple years, aside from the manmade mining pond. Likewise, the National Hydrography Dataset (NHD) shows no surface water features within the review area aside from the pond. Vegetation on the property appears to be a mixture of plant species typically found in uplands such as Alaska paper birch (Betula neoalaskana), quaking aspen (Populus tremuloides), and white spruce (Picea glauca). Based on the best available information, there are no indications that wetlands are present within the review area. Therefore, the subject property does not appear to contain waters of the U.S., including wetlands, under the Corps of Engineers (Corps) regulatory jurisdiction.
