MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹POA-2024-00337, MFR 1 of 1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

- a. The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under the Rivers and Harbors Act of 1899 in the review area). The vegetation, hydrology, and soil of the 4.03-acre review area does not meet the indicators of a wetland, therefore there are no wetlands in the review area. Additionally, there is no hydrology that suggests there are any bed and banks or ordinary high-water mark that would suggest any surface water flow (refer to section 10. OTHER SUPPORTING INFORMATION).

3. REVIEW AREA. The review area is located within Section 10, T. 18 N., R. 1 E., Seward Meridian; Latitude 61.6716° N., Longitude 149.2689° W.; near Fishhook, Alaska. The review area is approximately 4.03 acres.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The review area is entirely uplands and there are no aquatic resources in the review area that would connect with the Little Susitna River.⁶

10. OTHER SUPPORTING INFORMATION. Based on the wetland delineation report submitted to the Corps, the review area is dominated by Alaska paper birch (*Betula neoalaskana* - FACU), squashberry (*Viburnum edule* - FACU), prickly rose (*Rosa acicularis* - FACU), Northern oak fern (*Gymnocarpium dryopteris* - FACU), and bluejoint (*Calamagrostis canadensis* - FAC), resulting in vegetation not meeting wetland indicator tests (dominance test and prevalence index). Additionally, the soil in the review area does not meet the characteristics of hydric soils, and no wetland hydrology was observed within the soil profile or in the surrounding area. Based on the lack of hydrophytic vegetation, hydric soils, and hydrology, we have determined that the entirety of the 4.03-acre review area consists of uplands.
