# MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), 1 POA-2024-00598<sup>2</sup>

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>2</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>3</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA), the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

# 1. SUMMARY OF CONCLUSIONS.

a. The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under the Rivers and Harbors Act of 1899 in the review area).

Based on a review of the best available information, the review area is comprised entirely of uplands. The information available shows that the vegetation, soil, and hydrology would not meet wetland criteria. There are no waterbodies in the review area regulated under Section 10 of the Rivers and Harbors Act and no aquatic resources that would be regulated under Section 404 of the Clean Water Act.

- 3. REVIEW AREA. The review area is located within Section 5, T. 12 N., R. 3 W., Seward Meridian; Latitude 61.1578° N., Longitude 149.858058° W.; in Anchorage, Alaska. The review area is the subject property, which is approximately 3.25 acres.

- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW is Campbell Lake, which is approximately 2.7 miles from the review area. There are no aquatic resources in the review area and thus none that would connect to Campbell Lake or any other TNW.<sup>5</sup>

There is no aquatic resource in the review area that would connect to a TNW, interstate water, or the territorial seas.

# 10. OTHER SUPPORTING INFORMATION.

Qualified investigators conducted an on-site investigation at the subject property on September 6, 2024 and determined that the property lacks wetlands or other waters. The subject property has a peak elevation of approximately 120 feet above mean sea level (MSL) at the western property boundary, which drops 12 feet over 480 feet to a low point of 108 feet above MSL at the northern property boundary. The average slope of the subject property is approximately 2%. The property is predominantly vegetated by bluejoint grass (*Calamagrostis canadensis*) and, to a lesser extent, sapling Alaska paper birch (*Betula neoalaskana*) and various species of alder (*Alnus spp.*). Except for the small patch of forest in the southeast corner, the site was disturbed in 2012, removing vegetation that had previously been present. Each of the three sample plots used to characterize site conditions, including the one placed in the forested patch, indicated presence of uplands. Further evaluation of the desktop resources has also led to this conclusion. A ditch conveying flow southward near the eastern boundary of the subject property is not within the review area.

11. NOTE: The structure and format of this MFR were developed in coordination with the EPA and Department of the Army. The MFR's structure and format may be subject to future modification or may be rescinded as needed to implement additional guidance from the agencies; however, the approved jurisdictional determination described herein is a final agency action.
