MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), POA-2024-00323²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell quidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

a. The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under the Rivers and Harbors Act of 1899 in the review area).

Based on a review of the best available information, the review area is comprised entirely of uplands. The information available shows that the vegetation, soil, and hydrology would not meet wetland criteria. There are no waterbodies in the review area regulated under Section 10 of the Rivers and Harbors Act and no aquatic resources that would be regulated under Section 404 of the Clean Water Act.

- 3. REVIEW AREA. The review area is located within Section 32, T. 16 N., R. 4 E., Seward Meridian; USGS Quad Anchorage B-5; Latitude 61.43442° N., Longitude 148.76600° W.; Alaska Glacier Lodge, Account 16N04E32A006, Lot A6; 29979 E Knik River Road, near Palmer, Alaska. The review area is the subject property, which is approximately 0.94-acre.

- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW is the Knik River, which is approximately 0.62mile from the review area. There is a small ephemeral stream adjacent to the review area, which was rerouted around 2017 (more than 8 years ago). When it has flows, this ephemeral stream trickles down the mountain and appears to go underground before reaching Hunter Creek. We did not observe a visible stream path in any of the Google Earth imageries reviewed from 1985 to 2022).⁵
- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

There is no aquatic resource in the review area that would connect the area of fill into a TNW, interstate water, or the territorial seas.

⁵ This MFR should not be used to complete a new stand-alone TNW determination. A stand-alone TNW determination for a water that is not subject to Section 9 or 10 of the Rivers and Harbors Act of 1899 (RHA) is completed independently of a request for an AJD. A stand-alone TNW determination is conducted for a specific segment of river or stream or other type of waterbody, such as a lake, where upstream or downstream limits or lake borders are established.

10. OTHER SUPPORTING INFORMATION.

USACE conducted a field investigation on August 6, 2024, and walked through the area that was filled to construct the helipad (0.94-acre). USACE also walked outside the area of fill to compare vegetation in undisturbed sites located in similar elevation and geomorphologic position (reference areas). These areas do not contain hydrophytic vegetation. These areas are predominantly vegetated by bluejoint grass (*Calamagrostis canadensis*), alder (*Alnus spp.*), cow parsnip (*Heracleum maximum*), and wild raspberry (*Rubus idaeus*). Most of these plant species are not indicators of wetlands.
