SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are “*navigable waters of the U.S.*” within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

- Waters subject to the ebb and flow of the tide.

Explain: The proposed project would occur below the plane of the high tide line (approximately +13.2 feet above the 0.0 elevation line) and the mean high water (approximately +9.5 feet above the 0.0 foot elevation line) in Lisianski Inlet, which is a navigable water of the United States. Lisianski Inlet is directly connected to the Gulf of Alaska through Cross Sound which is a part of the Pacific Ocean. All areas identified above are subject to the ebb and flow of the tide.

Summarize rationale supporting determination: Lisianski Inlet is a navigable waterbody as explained in Section II A. There are anadromous fish steams within 2,200 feet of the proposed project location that support federally managed fisheries resources (i.e. Sockeye and Coho Salmon). Interstate and foreign travelers harvest salmon while engaging in guided recreation/sport fishing in the Pelican area. Fish that out-migrate from and in-migrate to these anadromous fish steams are caught by commercial and subsistence fishers in navigable waters (i.e. Lisianski Inlet, Cross Sound, and the Gulf of Alaska). Lisianski Inlet, Cross Sound, and the Gulf of Alaska are used to transport commerce such as goods and services via ships and barges. Also, these waters are used by Alaska Marine Ferry ships and by commercial guides to transport tourists to Pelican, nearby recreational establishments, and other Alaska communities.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

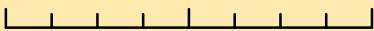
