SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are "*navigable waters of the U.S.*" within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area. [Required]

- Waters subject to the ebb and flow of the tide.
- Waters are presently used, or have been used in the past, or may be susceptible for use to transport interstate or foreign commerce: Port Alexander qualifies as navigable water of the United States, because it is a water body subject to the ebb and flow of the tide. Also, Port Alexander is presently used, and has been used in the past, and may be susceptible for use to transport interstate or foreign commerce. There are anadromous fish streams (113-11-10100, 113-11-10090 109-10-10010) within 3 - 9 miles of the proposed project location that support federally managed fisheries resources (i.e. chum, coho and pink salmon). Interstate and foreign travelers harvest salmon while engaging in guided recreation/sport fishing in the Port Alexander area. Fish that out-migrate from and in-migrate to these anadromous fish streams are caught by commercial fishers in navigable waters (i.e., Chatham Strait). Chatham Strait is used to transport commerce such as goods and services via ships and barges. Also, these waters are used by ocean going cruise ships or by commercial guides to transport tourists to Southeast Alaska communities in the project vicinity for recreation such as wildlife viewing, hunting, and kayaking.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

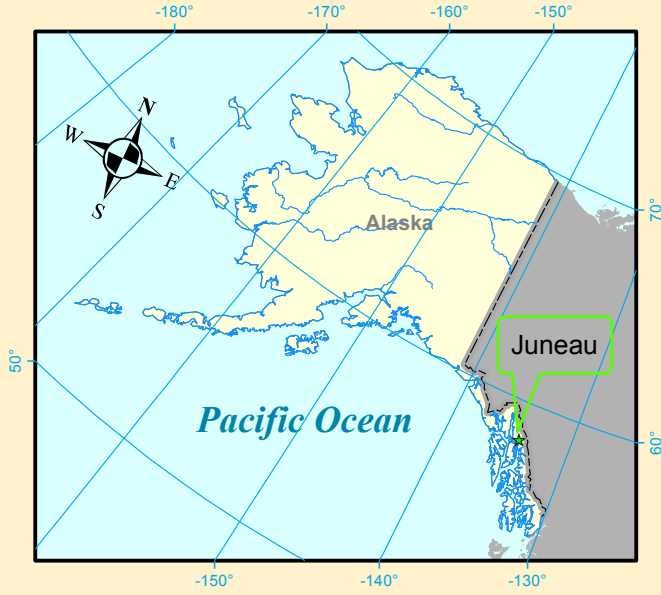

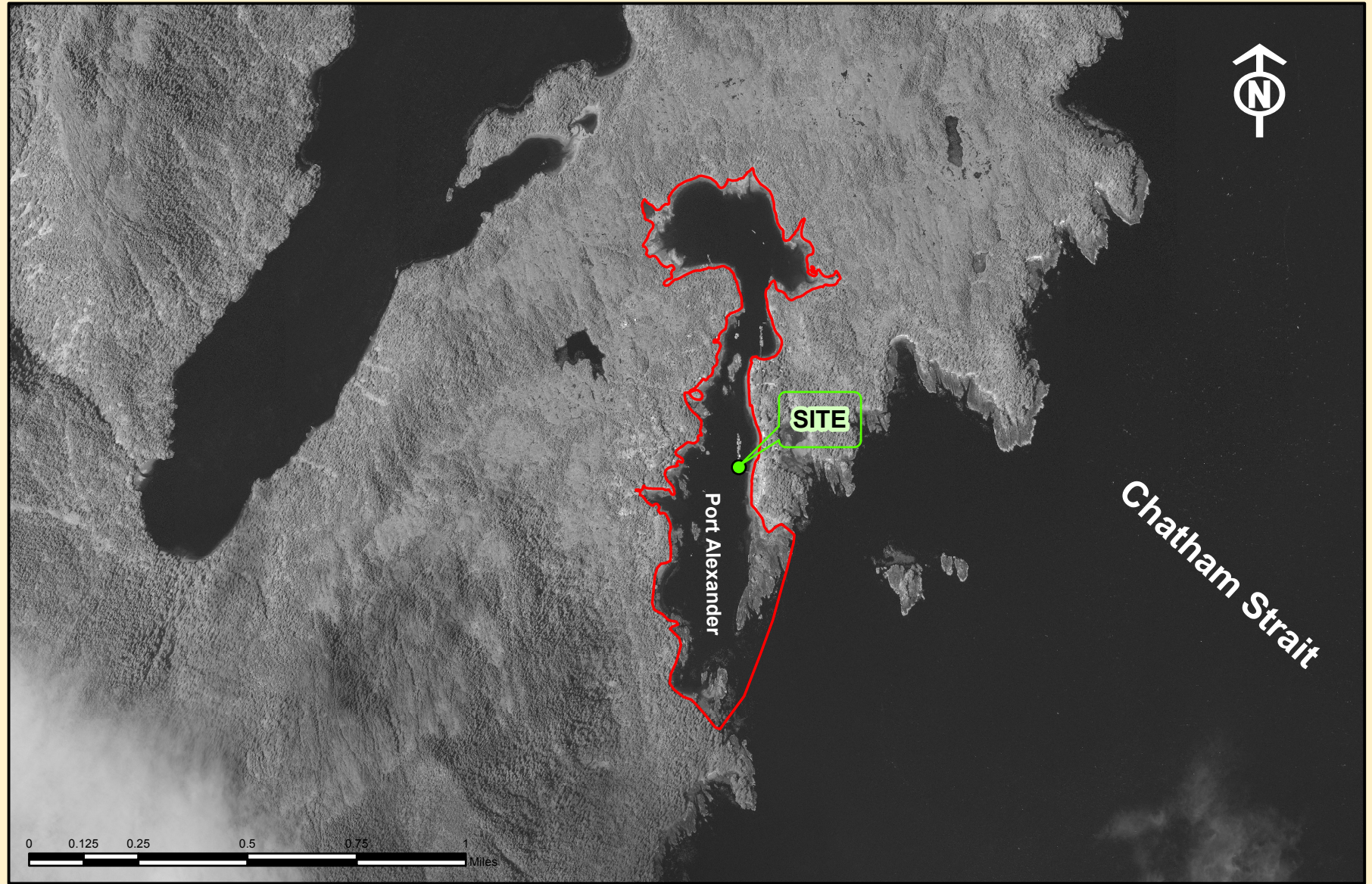
