Waters are presently used, or have been used in the past, or may be susceptible for use to transport interstate or foreign commerce. Explain: Turnagain Arm, one of the branching arms of Cook Inlet, borders the Municipality of Anchorage and the Kenai Peninsula Borough. Marine traffic in this area consists of both commercial and recreational vessels and includes the ships traveling to and from the Port of Anchorage. The only intermodal deepwater port in Alaska, the Port of Anchorage receives about 90% of Alaska's merchandise goods and serves over 250 communities. The Department of Defense has designated the Port of Anchorage a National Strategic Seaport, one of 19 deemed vital to U.S. National Defense. Additionally, Anchorage is site to the only active Foreign Trade Zone in Alaska. Cook Inlet has a tidal range of 10 meters, one of the largest in the world; the Corps of Engineers conducts maintenance dredging of this waterway in support of Alaska's commerce.

SECTION III: CWA ANALYSIS

Summarize rationale supporting determination: By definition, navigable waters of the United States are those waters that are subject to the ebb and flow of the tide and/or are presently used, or have been used in the past, or may be susceptible for use to transport interstate or foreign commerce (33 CFR 329.4). Because Turnagain Arm is a tidally-influenced water that is used for both interstate and foreign commerce, it should be considered a navigable water subject to Corps jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
