SECTION III: CWA ANALYSIS

A. TNWs AND WETLANDS ADJACENT TO TNWs

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. Identify TNW: Berners Bay/Lynn Canal/Taiya Inlet

Summarize rationale supporting determination: Berners Bay/Lynn Canal/Taiya Inlet are waterbodies that are subject to ebb and flow of the tide. There are anadromous fish streams (Sawmill Creek, Antler River, Lace River, Berners River, Johnson Creek, Slate Creek, Sweeny Creek, Sherman Creek, and Katzehin River) within the proposed project area that support federally managed fisheries resources (i.e. Chinook, Chum, Coho, Pink, and Sockeye salmon). Interstate and foreign travelers harvest salmon while engaging in sport fishing in the proposed project vicinity. Fish that migrate from and inmigrate to these anadromous fish streams are also caught by commercial fishers in these tidal waters and other nearby waters (e.g. Favorite Channel, Stephens Passage, Chilkoot Inlet, and Lutak Inlet). These tidal waters are used to transport commerce such as goods and services via ships and barges to Northern Southeast Alaska communities. Also, commercial guides use these tidal waters to transport tourists (foreign and interstate) via marine vessels to engage in recreation such as wildlife viewing, hunting, and fishing.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The wetlands at the review site are located along the coast of Berners Bay/Lynn Canal, which are Traditional Navigable Waters.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
