SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area. [Required]

Explain: The proposed project would occur below the mean high water mark (approximately +13.1 feet above the 0.0 foot contour) in Portage Bay, which is a navigable water of the United States. There are anadromous fish streams (Jenny Creek and Sitkum Creek) within approximately 1 mile of the proposed project location that support federally managed fisheries resources (i.e. Coho, Pink, and Chum salmon). Interstate and foreign travelers harvest trout and salmon while engaging in sport fishing in the proposed project vicinity. Fish that migrate from and in-migrate to these anadromous fish streams are also caught by commercial fishers in these tidal waters and other nearby waters (e.g. Frederick Sound). These tidal waters are used to transport commerce such as goods and services via ships and barges to Kake. Also, commercial guides use Portage Bay to transport tourists (foreign and interstate) via marine vessels to engage in recreation such as wildlife viewing, hunting, and fishing.

Summarize rationale supporting determination: The proposed project would involve dredging approximately 850 cubic yards of material from approximately 0.83 acres from the intertidal area below the plane of the high tide line (approximately +18.0 feet above the 0.0 foot contour) and the mean high water mark (approximate elevation +13.1 feet above the 0.0 foot contour). Work in waters of the United States would include discharging approximately 850 cubic yards of dredged material into 0.2 acres and placing concrete fill material into approximately 0.83 acres below the HTL and MHW in Portage Bay, which is a water subject to the ebb and flow of the tide.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


