**SECTION II: SUMMARY OF FINDINGS**

**A. RHA SECTION 10 DETERMINATION OF JURISDICTION.**

There are “*navigable waters of the U.S.*” within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area. [Required]

- Waters subject to the ebb and flow of the tide.
- Waters are presently used, or have been used in the past, or may be susceptible for use to transport interstate or foreign commerce. Explain: The proposed project would occur below the plane of mean high water (approximately +14.8 feet above the 0.0 foot contour) in Auke Bay, which is a navigable water of the United States. There are numerous anadromous fish streams (e.g. Auke Nu Creek, Bay Creek, Auke Creek, Casa Del Sol Creek, and Mendenhall River), within 0.5 – 2 miles of the proposed project location that support federally managed fisheries resources (i.e. pink, chum, coho, and sockeye salmon). Interstate and foreign travelers harvest salmon while engaging in guided recreation/sport fishing in the Juneau/Auke Bay area. Fish that out-migrate from and in-migrate to this anadromous fish stream and others within 1 mile of the project site are caught by commercial fishers in navigable waters (i.e., Auke Bay, Fritz Cove, Stephens Passage, Favorite Channel, Saginaw Channel, and Lynn Canal). Gastineau Channel, Auke Bay, Stephens Passage, Favorite Channel, Saginaw Channel, and Lynn Canal are used to transport commerce such as goods and services via ships and barges. Also, these waters are used by ocean going cruise ships or by commercial guides to transport tourists to Juneau and other Southeast Alaska communities in the project vicinity for recreation such as wildlife viewing, hunting, and kayaking.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
