Summarize rationale supporting determination: Gastineau Channel qualifies as navigable water of the United States, because it is a water body subject to the ebb and flow of the tide. Also, Gastineau Channel is presently used, and has been used in the past, and may be susceptible for use to transport interstate or foreign commerce. There are anadromous fish streams within 1 mile of the proposed project location that support federally managed fisheries resources (i.e. Chinook, sockeye, chum, coho and pink salmon). Interstate and foreign travelers harvest trout and salmon while engaging in guided recreation/sport fishing in the Juneau area. Fish that out-migrate from and in-migrate to these anadromous fish streams are caught by commercial fishers in navigable waters (i.e., Gastineau Channel, Stephens Passage, Favorite Channel, Saginaw Channel, and Lynn Canal). Gastineau, Stephens Passage, Favorite Channel, Saginaw Channel, and Lynn Canal are used to transport commerce such as goods and services via ships and barges. Also, these waters are used by ocean going cruise ships or by commercial guides to transport tourists to Juneau and other Southeast Alaska communities in the project vicinity for recreation such as wildlife viewing, hunting, and kayaking. Gastineau Channel has been used in the past for similar purposes, including the transport of gold ore for the Alaska Juneau and Treadwell Mines.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The wetlands that occur on the tract are approximately 640 feet from the high tide line (approximate elevation +20.8 feet above the 0.0 foot contour) of Gastineau Channel.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


