Identify TNW: Elfin Cove

Summarize rationale supporting determination: Elfin Cove is a Navigable waterbody as explained in Section II A. There are anadromous fish steams within 2.6 miles of the proposed project location that support federally managed fisheries resources (i.e. Pink and Chinook Salmon). Interstate and foreign travelers harvest salmon while engaging in guided recreation/sport fishing in the Elfin Cove area. Fish that out-migrate from and in-migrate to these anadromous fish steams are caught by commercial and subsistence fishers in navigable waters (i.e. Icy Strain and Cross Sound). Elfin Cove and Icy Strait and Cross Sound are used to transport commerce such as goods and services via ships and barges. Also, these waters are used by ocean going cruise ships and by commercial guides to transport tourists to Elfin Cove, Juneau, Sitka, Gustavus and other tourism related establishments in the project vicinity for recreation such as wildlife viewing, hunting, and kayaking.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
