Work involves dredging approximately 500 CY of accumulated debris and sediment from the river for the creation of a boat channel. Additionally, the project includes the discharge of approximately 200 CY of rip-rap above and below OHW including geotextile fabric for riverbank stabilization, as well as the temporary placement of two 12 inch pilings with a 12 foot wide bumper wall within the river constructed of untreated wood.

##### 2. Wetland adjacent to TNW Not Applicable. There are no adjacent wetlands in the review area.

Summarize rationale supporting conclusion that wetland is “adjacent”: The barge landing project involves the placement of rip-rap work and dredging of accumulated sediment and debris which will occur on the riverbank of the TNW and within the river itself.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION: NOT APPLICABLE. THE ONLY AFFECTED WATERS ARE LOCATED IN THE TNW. THERE ARE NO ADJACENT OR ABUTTING WETLANDS.**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
