C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant

nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Investigation of Potential Hydrologic Connection:

During the Corps site visit on June 9, 2016, the Corps observed that the subject wetland was in a topographic depression surrounded by uplands. The site visit consisted of trying to find a potential hydrologic connection between the subject wetland and waterbody and the Knik Arm, a traditional navigable water (TNW).

After a review of all available data (the applicant's submitted report, Corps of Engineer's ORM mapping, Fish and Wildlife Service (FWS) online National Wetland Inventory (NWI) mapper, NRCS Web Soil Survey and Google Earth aerial imagery), it was determined there is no potential connection between the subject wetland and waterbody and the Knik Arm. The subject wetland is in a depression with no signs of drainages for water to flow from it. The subject waterbody's primary source of water is from the ~90,000 gallons of water that is discharged daily from the JBER Water Treatment Plant and terminates at the subject wetland.

The wetland and waterbody are geographically, ecologically, and hydrologically isolated from any TNWs or RPWs. The use, degradation or destruction of this wetland and waterbody would not affect interstate commerce. This wetland and waterbody is not used by interstate or foreign travelers for recreational or other purposes. No fish or shellfish are or could be taken and sold in interstate or foreign commerce.
