EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The sewer and water project would be imbedded along roads and driveways throughout the community. Previous fill is evident in the area within the individual lots showing gravel, upland grasses in yards, with birch trees (*Betula papyrifera*) and white spruce (*Picea glauca*).
